

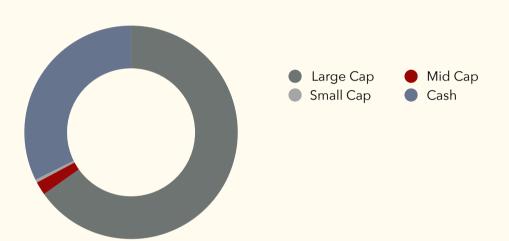

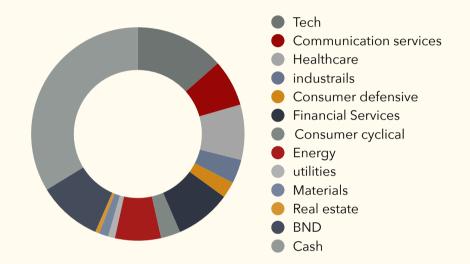

## **Management Commentary**;

**Negatives:** We underperformed the SPX by 0.79% for the month of July. The fund remains overweight in energy stocks at 6.55%, with our target percentage being 4.11%. We remain overweight in legacy positions PYPL and DIS, which despite beating estimates this month, failed to impress the market. We are underweight in all other sectors except cash, as we have been expecting a pullback for some time as we wait for tariffs to show up in inflation data and the market to correct.

**Positives:** We continue to outperform the S&P 500 for the year and since the start of reporting. Since inception, we have consistently beaten the index and paid a higher dividend. We have reduced much of our holdings based on what we believe is an unsustainable rally and now have 32.34% cash reserves ready to take advantage of opportunities and volatility this year. The notable changes this month include: cash increasing by 32.15%, Small Cap holding -54.9% and Consumer Cyclical -27.92%. We added short-term bonds as a diversification to cash. We have been NET sellers this month, reducing our holding to balance the portfolio. We now continue to have little direct exposure to China (except LVS, which reduced this month), but maintain positions in Canada (SU) & Mexico (STZ), and so do not expect to be disproportionately disadvantaged by tariffs. The dividend improved significantly to 3.23%, and increased further compared to the S&P 500's 1.24%, and our Beta continues to fall and is now well below the 1 range at 0.5818 due to our very large cash position, bond holdings and the sale of more volatile growth companies. We expect the SPX to fall in the current months once inflation begins to rise in the 2nd half of the year due to tariffs, but of course, this is uncertain at this time.

**Conclusion**: We are satisfied with the fund's performance this month, increasing cash, reducing our volatility, and increasing our dividend compared to the SPX. We have adopted a risk-off approach and will continue to monitor the situation but are exceptionally well placed for a pullback. We, of course, are heavily out of the market based on our forecasts of a pullback in the mid-term.

- (2) For the purpose of determining the equity and debt exposures, investments are valued based on stock price after the market closes on the last day of the month, should the market be closed on this date, the close price on the previous trading day will be used.
- (3) Large Cap is defined by companies with a Market Capitalisation of greater than \$5 Billion, Mid Cap is defined by companies with a Market Capitalisation of no greater than \$5 Billion but greater than \$1 Billion and Small Cap is defined by companies with a Market Capitalisation less than \$1 Billion.
- (4) Portfolio composition is calculated using the publicly disclosed sector allocation for each holding as of the date of this report. A position in an issuer is only assigned to a sector once it has been publicly disclosed.
- (5) Where the Company holds shares in an ETF or a Publicly Traded Investment Holding Company, given the complex composition of those holdings it is not possible for the percentage allocated per sector to be valued precisely, therefore the combined value of these positions has been pro-rated based on the SP500 sector composition. These will be recalculated in January each year. For any ETF holding using the NSDAQ 100 or similar as its benchmark, given its Tech sector bias, the full amount has been allocated to the Tech percentage of the Company composition. The company may provide weightings for any ETF or similar upon request and no assumptions should be made regarding the weighting in the sector allocation.
