





# **Management Commentary**;

**Negatives:** The fund continued to experience headwinds this month due to uncertainty of the consequences of tariffs with the USA's closest trading partners and a dislike for companies in the A.I. space. NVDA, TSM & AVGO and most of the MAG7 have been hit especially hard. Opportunistic purchases have reduced the cash position to 3.97% down from 8.68% and have raised the portfolio's Beta slightly above the target range of 1. Despite the dividend interest rate increasing, it remains slightly under the target rate of 2.67% for April. We outperformed the SPX by 1.19% for the month of March. We do not expect tariffs to depress the market as being feared by the media and we see reciprocal tariffs as ultimately good for the US economy and will be evidenced in the 2nd half of the year.

**Positives:** We continue to outperform the SP500 for the year and since the start of reporting by 18.35%. Since inception, we have consistently beat the index, paid a higher dividend, and have consistently had a lower Beta despite the aforementioned headwinds. We have 4% cash reserves ready to take advantage of opportunities and volatility this year. The notable changes this month include: cash decreasing by 54%, Small Cap holding -13.95%, Consumer Defensive +20% through additions of WMT & STZ & Bonds -15.26%. We strategically added to existing positions in out-of-favour stocks. We now have no exposure to China (except LVS), but maintain positions in Canada (SU) & Mexico (STZ), and so do not expect to be disproportionately disadvantaged by President Trump's tariffs. The dividend improved to 2.35% greater than the SP500's 1.33%. U.S.D. has weakened and provided an opportunity to convert other currencies into our primary currency, USD, and positions that are USD-denominated but primarily generate revenue in a currency other than USD have experienced a rise in share price over the previous month.

**Conclusion**: We are somewhat disappointed with the fund falling slightly this month but our losses are less than our benchmark so should be seen positively. Having added to quality positions last month, I remain confident about the fund's continued success.

- (1) Performance results are presented on a net-of-fee basis. The author believes this is an accurate representation of the performance of the Company. Performance data and other information contained herein are unaudited but the author has undertaken to ensure the information is accurate except where decimal rounding is used. Performance is based on the dollar return for the specific period, including any dividend, interest or bond payments received by the Company, calculated from the beginning to the end of such period on a non-accural basis, the aforementioned is only recorded upon receipt of payment.
- (2) For the purpose of determining the equity and debt exposures, investments are valued based on stock price after the market closes on the last day of the month, should the market be closed on this date, the close price on the previous trading day will be used.
- (3) Large Cap is defined by companies with a Market Capitalisation of greater than \$5 Billion, Mid Cap is defined by companies with a Market Capitalisation of no greater than \$5 Billion but greater than \$1 Billion and Small Cap is defined by companies with a Market Capitalisation less than \$1 Billion.
- (4) Portfolio composition is calculated using the publicly disclosed sector allocation for each holding as of the date of this report. A position in an issuer is only assigned to a sector once it has been publicly disclosed.
- (5) Where the Company holds shares in an ETF or a Publicly Traded Investment Holding Company, given the complex composition of those holdings it is not possible for the percentage allocated per sector to be valued precisely, therefore the combined value of these positions has been pro-rated based on the SP500 sector composition. These will be recalculated in January each year. For any ETF holding using the NSDAQ 100 or similar as its benchmark, given its Tech sector bias, the full amount has been allocated to the Tech percentage of the Company composition. The company may provide weightings for any ETF or similar upon request and no assumptions should be made regarding the weighting in the sector allocation.
